Important 2018 Income Tax Information

BOND FUND

In some states, the amount of ordinary income shareholders receive from US Treasury and certain Federal obligations is exempt from state income tax. Of the ordinary income dividends received from William Blair Bond Fund in 2018, **3.85%** was derived from US Treasury obligations.

INCOME FUND

In some states, the amount of ordinary income shareholders receive from US Treasury and certain Federal obligations is exempt from state income tax. Of the ordinary income dividends received from William Blair Income Fund in 2018, **1.68%** was derived from US Treasury obligations.

LOW DURATION FUND

In some states, the amount of ordinary income shareholders receive from US Treasury and certain Federal obligations is exempt from state income tax. Of the ordinary income dividend received from William Blair Low Duration Fund in 2018, **none** was derived from US Treasury obligations.

MACRO ALLOCATION FUND

In some states, the amount of ordinary income shareholders receive from US Treasury and certain Federal obligations is exempt from state income tax. Of the ordinary income dividends received from William Blair Macro Allocation Fund in 2018, **11.32%** was derived from US Treasury obligations.
